Important notes

How to complete this form and access your transcript

1. If you had a hearing and gave evidence before Commissioner Mullighan, you are the only one who may obtain a copy of your transcript of evidence.
2. It is not possible to obtain copies of transcripts of evidence of persons other than yourself.
3. As part of this application, please provide certified copies of proof of identity containing your photograph and signature. For example:
 - your driver's licence or passport; and
 - a government ID card to entitlement to a financial benefit, pension etc.

Please Note: To protect your privacy you must provide identification documents, otherwise we will not send you a copy of your transcript.

4. If you are assisting someone else in obtaining their transcript of evidence, the person who gave evidence **must** sign this form.
5. If you are applying on behalf of someone under a legal disability, please supply evidence of your appointment such as:
 - an Order issued by the Guardianship Board; or
 - a Power of Attorney document.
6. If you have changed your name, please supply proof of name change, e.g.:
 - Marriage Certificate; and/or
 - Deed Poll.
7. If your application is successful, a copy of your transcript will be posted to the address submitted by you on this form. There is no charge for this service.
8. Depending upon what you said during your evidence, the disclosure of the transcript of evidence by you to other people, may amount to defamation and you may be exposing yourself to civil liability. If in doubt, you should seek your own legal advice, which would be at your expense.
